Sealed bids from suppliers will be received by the Flowery Branch City Clerk's Office, at 5517 Main Street, Flowery Branch, Georgia 30542 until 3:00 p.m. legally prevailing time on **Wednesday, July 16, 2014** for:

Spring Street Bridge Construction

The intent of this solicitation is to select one contractor for the demolition and removal of the existing Spring Street culvert and site preparation and grading as described in the plans dated 3/18/14 as designed by Pond & Company, and the design and construction of the Spring Street Bridge to replace this culvert.

The bids for each commodity will be publicly opened and read on **Wednesday, July 16, 2014 at 3:15 p.m.** No extension of the bidding period will be made.

It is anticipated that this project will be awarded on August 7, 2014.

Bid bonds in the amount of not less than 5% of the base bid must be submitted with each bid. Failure to supply bond will force your bid to be declared nonresponsive.

The successful bidder shall provide a 100% Payment and a 100% Performance Bond at the signing of the contract. Failure to supply bonds will result in default of contract. Successful bidders shall provide insurance in the amount of at least one million dollars (\$1,000,000.00).

A **mandatory** pre-bid conference will be conducted on **Friday, June 27, 2014**. The conference will begin at 2:00 PM at Flowery Branch City Hall, 5517 Main Street, Flowery Branch, GA 30542. **Only bidders in attendance for the entire meeting will be allowed to bid on the project.** All prospective bidders should visit the project site prior to the pre-bid conference. All questions relating to the bid must be submitted in writing by Wednesday, **July 2, 2014 at 5 pm**. Responses will be sent to pre-bid attendees on Monday, **July 7, 2014**.

Contract, if awarded, will be on a lump sum basis or individual item basis, whichever is in the best interest of the Owner. No bid may be withdrawn for a period of (30) thirty days after time has been called on the date of opening. The Owner reserves the right to include any combination, in whole or partially, of the work represented by the Bid Schedules in the Bid.

The Owner reserves the right to reject any or all bids and to waive technicalities and informalities.
